

Preamble

The Indian National Science Academy (INSA) is a premier scientific learned body (established in 1935) representing all branches of science —Physical and Biological Sciences including Engineering, Medicine and Agricultural Sciences. The Academy has been promoting scientific cooperation with Academies/Organisations of several countries the world over. The Academy has links with the Academies and Organisations in Asia, Europe and South America. These programmes provide opportunities to scientists working in various scientific institutions and organizations in the country for exchange of ideas, knowledge, establish new links, strengthen old links and undertake joint projects with their research partners in leading laboratories and institutions abroad. - 6. The subsequent installments will be released on completion of the work as set out in the plan submitted at the outset by the Designate Fellow.
- 7. A progress report giving details of documentation and writing carried out, places visited, persons met etc. in connection with the award must be sent to Sahapedia before the release of the second installment. A detailed plan of the expenditure incurred as a part of the assignment must be provided as well.
- 8. All material created and curated for the module will be uploaded to Sahapedia's online portal. Sahapedia is committed to the Creative Commons approach, to maximize the potential of the Internet to widen access to research, knowledge and artistic creativity, with full credit to creators.
