

AGREEMENT

Agreement number:

This agreement is executed on this day of 19th May 2017 between:

Community Radio Association (CRA), registered as Societies Registration Act 1860 , Registration No.S/606/Distt.South/2011 Date of Registration 23rd August 2011, at South District Government of NCT of Delhi (hereinafter referred to as "CRA" as the context may require and which expression shall include its successors and permitted assigns) **of the FIRST PARTY; AND Banasthali Vidyapith**, Station Director, Radio Banasthali (Banasthali Community Radio Station), Banasthali, Niwai, District- Tonk

Hereinafter referred to as "**Second party**" which expression shall unless repugnant to the context or meaning thereof, include its successors and permitted assigns) **OF THE SECOND PARTY**

CRA and Second Party are hereinafter collectively referred to as the "**Parties**" and individually as a "**Party**".

RECITALS

- a. WHEREAS CRA wishes to retain the services of the Second Party for the purposes of furthering and attaining the project of broadcast of a radio series Full On Nikki, developed by UNICEF and BBC Media Action as specified in this Agreement.

- b. AND WHEREAS Second Party has agreed to provide CRA with the said Deliverables as per the terms and conditions of this Agreement;
- c. AND WHEREAS CRA and the Second Party have now agreed to set out the terms and conditions of this Agreement as per the clauses below:

1. Engagement

- a. CRA hereby engages Second party to perform the services and ensure the completion of deliverables ("**Deliverables**") as specified in Attachment A and any related services as requested by CRA, and Second Party hereby accepts such engagement. Second Party shall perform its services in accordance with the timeline as described in Attachment A or as otherwise specified by CRA.
- b. Second Party represents and warrants that it shall not take any actions that would harm the interests, or reputation of CRA or its affiliates or that would violate any applicable laws or regulations.
- c. The programs produced by the Second Party shall be available for use by other interested parties and there will be no copyright on the programs.
- d. CRA to provide the relevant content from UNICEF to the Second Party.
- e. The agreement is valid for a project period of ten months

2. Term and Termination

- a. This Agreement shall begin on 9 June 2017 and end upon completion of Second Party's services on 8 April 2018 and approval and acceptance by CRA of all deliverables, unless otherwise terminated or extended, in accordance with the terms of this Agreement.
- b. Notwithstanding anything to the contrary, the engagement of Second Party shall be at the sole discretion of CRA, and CRA may terminate engagement of Second Party at any time upon notice, either "for cause" or "without cause." For termination other than "for cause" as determined by CRA in its sole discretion, CRA will give Second Party 30 days notice of termination (otherwise a notice period is not required). Second Party also may elect to terminate this Agreement by giving CRA two weeks' notice of termination. In the event of termination, Second Party will be entitled to compensation earned prior to the date of termination, computed pro-rata as appropriate, and subject to CRA's right to refund. Other than as just described, Second Party shall not be entitled to any other compensation upon termination.
- c. Second Party is engaged by CRA as independent Second Party and nothing in this Agreement shall be construed to deem the relationship between the Parties to be one of principal and agent, or employer and employee.

3. Compensation

In consideration for all services rendered by Second Party under this Agreement, CRA agrees to pay Second Party the compensation (which is exclusive of applicable taxes) specified below. CRA agrees to reimburse Second Party for any expenses that have been prior approved by CRA in writing. Second Party shall present CRA with appropriate documentation including receipts. The program agreement is valid for a period of ten months (three fresh episodes per week of 13 minute duration to be supplemented by a 7 minute community vox pop and narration). In case of delays/extension, the same terms and conditions will be continued (with no extra payment and save deliverables).

The total agreement amount will not exceed Rs. 1, 15,000 (Rupees One lac fifteen thousand only) subject to deduction of applicable taxes as per statutory requirements.

4. Payment Terms

Based on deliverables identified in **Attachment A**, the Second party will receive the following support for implementing the project

The community radio stations will:

- Broadcast:
 - Three ready episodes of Full On Nikki per week.
 - Each broadcast will involve airing the 13-minute episode followed by 7 minutes of community interaction as per a pre-determined broadcast schedule.
- Produce:
 - Introduction and ending segments for each broadcast with community vox pop
 - 7 minutes of community interaction
- Promote:
 - Air Full On Nikki promos atleast three weeks in advance the launch date
 - Air AdhaFULL jingles
 - Display program posters at the station premises and other locations in the community.

The payment terms and are detailed below –

- 1- Compensation: User agrees to release
 - **First Instalment:** Rs. 15,000 at the time of signing of MOU.
 - **The balance of 100,000 will be paid in three instalments at the end of each quarter upon submission of quarterly reports.**
 - **The taxes will be deducted as per norms**

5. Contract Period

The agreement will be valid for ten months. The detailed timelines are provided in **Attachment B.**

6. Indemnification

Second Party shall defend, indemnify and hold harmless CRA, its officers, directors, affiliates, employees, agents, assigns and representatives from and against any and all claims, actions, damages, costs and expenses (including, but not limited to, reasonable attorneys' fees) arising out of or in connection with any breach by Second Party of any of Second Party's representations or agreements or the performance of Second Party's services under this Agreement. This paragraph shall survive any termination of this Agreement.

As timing of the project is very important, the Second Party understands and undertakes to compensate CRA for all reasonable and consequential losses incurred by it if the project is not completed within the time limit mentioned in the contract.





The tentative broadcast schedule for Radio Banasthali (Banasthali Community FM Radio station) is as under:

Launch Date: 9 June 2017

Broadcast start date: 19 June 2017

Deliverables:

The community radio stations will:

- Broadcast:
 - Three ready to air episodes of Full On Nikki per week.
 - Each broadcast will involve airing the 13-minute episode followed by 7 minutes of community interaction as per a pre-determined broadcast schedule.
- Produce:
 - Introduction and ending segments for each broadcast
 - 7 minutes of community interaction
- Promotion:
 - Air Full On Nikki promos for upcoming episodes
 - Air AdhaFULL jingles
 - Display program posters at the station premises and other locations in the community.

- Reporting
 - Log of Quarterly number of calls received
 - Two stories of change/ anecdotes
 - Photos in field or with community

ATTACHMENT B for UNICEF Full On Nikki MoU

1. This Agreement is valid for a period of ten months (shall begin on 9 June 2017 and end upon completion of Second Party's services on 8 April 2018) for Rs. 1, 15,000(One Lakh and Fifteen Thousand only) and is inclusive of Taxes/GST. Two percent TDS will be deducted on the net amount payable by Community Radio Association(CRA) while making the payments. Invoices for payment shall be raised in the name of Community Radio Association by the Stations for payments along with quarterly reports. Once the reports are approved both by CRA and UNICEF, the payments will be automatically credited to the Radio Station's bank account.

2. There are Seventy Eight (78) total number of new episodes to be produced and broadcasted during the project. Every week Three new episodes are to be produced and broadcasted on gender empowerment that targets Indian adolescents – both boys and girls aged 10-19 and their parents.

3. Each new episode is of 20 minutes duration, out of this Thirteen(13) minutes duration of UNICEF Full On Nikki pre-recorded programme from the 78 programmes provided to the Stations in three pen drives and further Seven(7) minutes community vox pop and narration at the Radio Station level through local resources is to be added.

4. To give due publicity to the UNICEF Full On Nikki project, four UNICEF Full On Nikki project Posters have been provided to Station by CRA. These are to be placed in the community in your listenership zone. Please also print (at Station's cost) one Flexi (6 Feet X 4 Feet or so) or a Standee size Flexi (which can be pasted on an old Standee Stand available with the Station). The posters as well as the Flexi/Standee Flexi will carry the Station name, day and time of the broadcast.

SC India and the Service Provider hereinafter are individually referred to as the "Party" and collectively as "Parties".

WHEREAS SC India is desirous of engaging the Service Provider to provide certain services as per the Terms of Reference ("**the assignment**")

NOW THIS AGREEMENT witnesses as under: -

1. **Terms of Reference (TOR)**

1.7 SC India hereby engages the Service Provider to complete the work as per the TOR to the satisfaction of SC India and the Service Provider has agreed to such engagement. The Parties agree that the matters specified in the TOR may be modified from time to time as per mutual agreement between SC India and Service Provider, and that the TOR, as amended from time to time, shall form an integral part of this Agreement.

2. **Fees**

2.1 SC India shall pay to the service provider an amount of **INR: 1,20,00.00** Rupees One lakh twenty thousand) inclusive of all, during the term of the assignment as per the attached budget.

2.2 Payments Terms:

- 50% on signing of the consultancy agreement – INR: 60,000
- 50% After completion of three month – INR: 60,000

2.3 The fees shall be paid on the basis of invoice raised by the service provider. The invoice must be accompanied by a time sheet and documentation proof of variable costs like travel and accommodation, etc.

2.4 Tax deductions will apply to the fees of the Service Provider in accordance with the prevailing Income Tax legislation/policy of the Government of India.

3. **Accountability and Support**

The Service Provider will work within overall SC India policies on a variety of issues including Child Protection Policy. The Service Provider shall also comply with any other information and advisory materials concerning the practices applicable followed by SC India that SC India may provide to the Service Provider from time to time.

4. **Confidential Information**

The Service Provider shall maintain in confidence and safeguard all information that the Service Provider may come to know as a result of this Agreement or otherwise about or relating to SC India, including all information provided by SC India for purposes of this Agreement (whether provided before or after the execution of this agreement). The Service Provider shall not, except with the prior written authorization of SC India, disclose, give or publish to any other person, firm or corporation nor shall the Service Provider use such information for its personal gain or benefit. This obligation of the Service Provider shall continue after expiration or termination of this Agreement, including any renewal thereof.

5. **Ownership of findings**

Any reports produced and data collected by Service Provider will be the property of the SC India and will not be published and disseminated by the Service Provider without prior written permission of SC India.

6. **Termination**

This Agreement may be terminated:

- A. by mutual consent given in writing and signed by both Parties hereto; or
- B. by either Party at will or without cause with not less than one month's written notice or fee in lieu of notice.
- C. By SC India, with 7 days notice, in case SC India finds that the work is not being implemented by the Service Provider, at least according to SC India's minimum standards and that the progress of the work is not satisfactory.
- D. By SC India, without any notice whatsoever, in case the Service Provider violates any policy of SC India.

7. **Relationship of the Parties.**

The Parties are independent entities and this Agreement is being entered into on a principal to principal basis. It is understood and acknowledged by the Service Provider that the Service Provider is not, by virtue of this Agreement, rendered a representative or agent or employee of SC India and the Service Provider hereby agrees not to make any such representation to any person or authority. The Service Provider has no right or authority to assume or create, in writing or otherwise, any obligation of any kind, express or implied, in the name of or on behalf of SC India, unless provided with an express written authority in advance by SC India to do so.


8. **Indemnity**

The Service Provider agrees to comply with all laws (including the laws of India) applicable to the performance of his obligations under this Agreement. In case however, SC India suffers any loss or damage or claim etc. of any nature whatsoever on account of any actions of the Service Provider, the Service Provider shall indemnify and hold harmless SC India in respect of such loss or damage or claim etc.

9. **Non-Exclusive and Non-Assignable.**

10. **Jurisdiction**



This Agreement shall be governed and construed in accordance with, and performance of all services hereunder are subject to, the laws of India and regulations of the Indian Government, relevant State Governments and its departments and agencies, and the rights and obligations of the Service Provider as well as those of SC India under or in connection with this Agreement shall be construed in accordance with the laws of India. Any disputes arising out of or in connection with this agreement shall be subject to exclusive jurisdiction of courts in Delhi and no other court(s) shall have jurisdiction.

11. **Failure to Enforce.**

The failure of either Party hereto to enforce at any time or for any period of time any provision(s) of this Agreement shall not be construed to be waiver of such provision(s) or of the right of such Party thereafter to enforce each and every such provision.

12. **Rights and obligations upon expiration or termination.**

Neither Party shall be liable by reason of the termination or expiration of this Agreement to the other Party for any compensation, reimbursement or damages for terminating this Agreement in accordance with the terms hereof on any account whatsoever. The termination of the Agreement shall however not affect the obligations of the Parties incurred prior to the termination

13. **Entire Agreement - Execution and Modification**

13.1 This Agreement contains and constitutes the entire and only Agreement between the Parties hereto with respect to the subject matter hereof, and any representation, terms or conditions relating thereto not incorporated herein, shall not be binding upon either Party. This Agreement wholly cancels, terminates and supersedes any and all previous agreements, negotiations, commitments and writings between the Parties in connection with the subject matter of this Agreement.

13.2 This Agreement shall not become effective or binding upon SC India until signed by an authorized signatory of SC India.

13.3 No change, modification, extension, renewal, ratification, rescission, termination, notice of termination, discharge, abandonment or waiver of this Agreement or any of the provisions hereof, nor any representation, promise or condition relating to this Agreement shall be binding upon SC India unless made in writing and signed on behalf of SC India by the aforementioned representative

14. **Severability.**

In case any provision in this Agreement shall be held invalid or unenforceable, the validity, legality and enforceability of the remaining provisions thereof will not in any way be affected or impaired thereby.



15. **Headings.**

- 15.1 All headings set forth in this Agreement are for convenience only and shall not affect the interpretation of this Agreement.
- 15.2 Any change in the above particulars shall forthwith be communicated in writing to the other Party.
- 15.3 Any such notice may be delivered personally or be sent by registered A/D mail, or facsimile transmission and shall be deemed to have been duly sent and served if personally delivered, when delivered; if by registered A/D mail, on dispatch thereof; and if by facsimile transmission when dispatched and electronically generated confirmation receipt is received by sender.

 - e. Anything amount to contempt of court.
 - f. Aspersion integrity of the President, Governors and Judiciary
 - g. Attack on Political Party by name
 - h. Hostile criticism on any State or the Centre.
 - i. Anything showing disrespect to the constitution or advocating change in the constitution by emergency of if the country is faced with a natural calamity such as floods, earthquake or cyclone.
 - j. Direct publicity for or on the benefit of an individual or organization which is likely to benefit only that individual or organization.
 - k. Trade names in broadcasts which amount to advertising directly (except in Commercial Services).





AND WHEREAS the Consultant approached SC BR with an assurance for successful completion of the work assignment.

NOW THIS AGREEMENT witnessed as under: -

1. Terms of Reference (TOR)

SC BR hereby engages the Consultant to complete the work as provided in Terms of Reference (as per attached sheet) (TOR) to the satisfaction of SC BR and the Consultant has agreed to such engagement. The Parties agree that the matters specified in the TOR may be modified from time to time as per mutual agreement between SC BR and the Consultant, and that the TOR, as amended from time to time, shall form an integral part of this Agreement.

2. Time Scale

The duration of the assignment will be from 01 May, 2015 and ending 31 December, 2015 unless terminated earlier as provided for in clause 6 below.

3. **Accountability and Support**

The Consultant will work within overall SC BR policies on a variety of issues including Child Protection Policy. The Consultant shall also comply with any other information and advisory materials concerning the practices applicable followed by SC BR that SC BR may provide to the Consultant from time to time.

4. **Confidential Information**

The Consultant shall maintain in confidence and safeguard all information that the Consultant may come to know as a result of this Agreement or otherwise about or relating to SC BR, including all information provided by SC BR for purposes of this Agreement (whether provided before or after the execution of this agreement). The Consultant shall not, except with the prior written authorization of SC BR, disclose, give or publish to any other person, firm or corporation nor shall the Consultant use such information for its personal gain or benefit. This obligation of the Consultant shall continue after expiration or termination of this Agreement, including any renewal thereof.

5. **Ownership of findings**

Any reports produced and data collected by consultant will be the joint property of the SC BR and Consultant, however content will not be published and disseminated by the Consultant without prior written permission of SC BR.

6. **Termination**

This Agreement may be terminated:

- A. by mutual consent given in writing and signed by both Parties hereto; or
- B. by either Party at will or without cause with not less than one month's written notice or fee (as specified in clause 7 below) in lieu of notice.
- C. By SC BR, with 7 days notice, in case SC BR finds that the work is not being implemented by the Consultant, at least according to SC BR's minimum standards and that the progress of the work is not satisfactory.
- D. By SC BR, without any notice whatsoever, in case the consultant violates any policy of SC BR.

7. **Fees**

The Consultant shall be paid **Rs.1, 69,000 as per details attached in ToR Annexure I**
Tax deductions will apply to the fees of the Consultant in accordance with the prevailing Income Tax legislation/policy of the Government of India.

SC BR will reimburse, subject to prior written approval having been obtained, expenses for reasonable accommodation, subsistence and travel if the Consultant is required by SC BR to undertake any field visits or related work.

9. Indemnity

The Consultant agrees to comply with all laws (including the laws of India) applicable to the performance of his obligations under this Agreement. In case however, SC BR suffers any loss or damage or claim etc. of any nature whatsoever on account of any actions of the Consultant, the Consultant shall indemnify and hold harmless SC BR in respect of such loss or damage or claim etc.

10. Non-Exclusive and Non-Assignable.

(a) The Parties agree that the appointment of the Consultant is non-exclusive.

(b) The Consultant acknowledges and confirms that the rights and obligations of the Consultant under this Agreement are personal in nature and the Consultant hereby agrees not to assign or transfer his obligations or interests or any part thereof to any person. The Parties agree that SC BR has the right to assign this Agreement or any interest therein to any of its affiliate organizations without having to obtain the consent of the Consultant.

11. Jurisdiction

This Agreement shall be governed and construed in accordance with, and performance of all services hereunder are subject to, the laws of India and regulations of the Indian Government, relevant State Governments and its departments and agencies, and the rights and obligations of the Consultant as well as those of SC BR under or in connection with this Agreement shall be construed in accordance with the laws of India. Any disputes arising out of or in connection with this agreement shall be subject to exclusive jurisdiction of courts in Delhi and no other court(s) shall have jurisdiction.

12. Failure to Enforce.

The failure of either Party hereto to enforce at any time or for any period of time any provision(s) of this Agreement shall not be construed to be waiver of such provision(s) or of the right of such Party thereafter to enforce each and every such provision.

No change, modification, extension, renewal, ratification, rescission, termination, notice of termination, discharge, abandonment or waiver of this Agreement or any of the provisions hereof, nor any representation, promise or condition relating to this Agreement shall be binding upon SC BR unless made in writing and signed on behalf of SC BR by the aforementioned representative

15. **Severability.**

In case any provision in this Agreement shall be held invalid or unenforceable, the validity, legality and enforceability of the remaining provisions thereof will not in any way be affected or impaired thereby.

16. **Headings.**

All headings set forth in this Agreement are for convenience only and shall not affect the interpretation of this Agreement.

2. That Radio Banasthali has agreed to broadcast (on air) 10 programmes per month from 01st May - 31st December, 2015, on the following terms and conditions:
 - i. That the proposed programmes will be broadcast in the available time slot as per programme schedule of Radio Banasthali.
 - ii. That the Programme cost will be shared by Save the Children and Banasthali Vidyapith on equal basis as per the details below:
 - a. Charges for one programme of 15-45 minute duration – Rs.4000/-
 - b. Save the Children will contribute Rs. 2000/- per programme
 - c. Programmes will be produced in consultation with Save the Children
 - d. Total 10 programmes will be aired per month 10 X 2000=Rs.20,000/- per month will be contributed by Save the Children(for 8 months Rs.1,60,000/-)
 - e. These charges are inclusive of production (Studio Charges, Anchor Charges, Travel of Volunteers and Expert cost as per Banasthali Vidyapith Radio Station's norms), Post Production (editing & mixing) and airing of programmes.
 - f. Save the Children will organize three programme production workshops for volunteers at Banasthali Vidyapith and expenses will be borne by Save the Children
 - iii. **Mode of Payment:** At the time of signing the agreement : 50%
After completion of one month: 25%
After completion of two month: 25%
Tax deductions will apply to the fees of the Consultant in accordance with the prevailing Income Tax legislation/policy of the Government of India.
 - (iv) Any Radio Programmes to be broadcast on Radio Banasthali by individual does not permit:-
 - a. Criticism of friendly countries.
 - b. Attack on religion of community
 - c. Anything obscene or defamatory
 - d. Incitement to violence of anything against maintenance of law and order
 - e. Anything amount to contempt of court.
 - f. Aspersion integrity of the President, Governors and Judiciary
 - g. Attack on Political Party by name
 - h. Hostile criticism on any State or the Centre.
 - i. Anything showing disrespect to the constitution or advocating change in the constitution by emergency or if the country is faced with a natural calamity such as floods, earthquake or cyclone.
 - j. Direct publicity for or on the benefit of an individual or organization which is likely to benefit only that individual or organization.
 - k. Trade names in broadcasts which amount to advertising directly (except in Commercial Services).
3. Save the Children and Banasthali Vidyapith may use these productions for various social campaigns. Copy of programme/productions material in terms of CDs/DVDs/Tapes will not be released before broadcast.
