










In accordance with the procedure of evaluation details in the advertisement, in the First phase technical and financial bid were made by various companies the Committee technically evaluated all the proposals and selected us for setting up a Centralized Solid biomedical waste treatment facility for Alwar-Bharatpur and 150 kms around it.



NOW, THEREFORE, in consideration of the premises and the mutual covenants Promises, assurances, representations and provisions set forth hereinafter, the parties hereto agree as follow:

1. That “the member” means private / Govt. hospital, nursing homes, pathology ,Labs, blood bank, Medical practitioners and all other solid bio-medical waste Generating institutions and/ of entities having place of business in and around 150 kms periphery of Alwar-Bharatpur
  2. That the firm has installed a centralized solid Biomedical waste treatment facility On its own cost for Alwar-Bharatpur on a leased land provided by Municipal Council.
  3. That the firm develop a “centralized bio medical waste treatment facility” and Install required equipments for proper disposal of Solid bio-medical waste as per Rules of 1998 after receiving the relevant permissions and authorizations from Various departments.
- That the transportation of the solid bio-medical waste shall be part of the responsibility of the firm. The firm will transport the segregated solid Bio-Medical waste from the doorsteps of the hospital to the treatment site. The firm Will make its own arrangement for the transportation of the waste. No untreated Bio-medical waste shall be kept stored beyond a period of 48 hours in Bio-medical Waste generating units.

5. That the member will have to keep their **segregated solid Bio-Medical was properly packed** and tagged as per guidelines of Rules of 1998 & keep it ready at their door step daily on scheduled time for transportation. The firm will not collect the waste if:-

- (a) It is kept open
- (b) It is not segregated
- (c) It is not packed, or
- (d) It is mixed with municipal solid waste or liquid waste.

6. That the member will arrange what so ever, non-chlorinated bags, containers of different colors code, labels, tags etc required for proper segregating, packing and labeling of their solid bio-medical waste as laid down in Rules of 1998.

7. That the member will not be responsible for any civil or court liability arising of transportation ,accident or any other event during the disposal of solid biomedical Waste. Pre-transport hazards & risk thereto if any, shall be on the part of the member & firm shall not be liable thereto.

8. This project is for treatment of solid biomedical waste only. Other type of waste (such as liquid waste and municipal waste) shall be treated or disposed off by the members at their own arrangements. The firm will not be responsible for any liabilities other then treatment of solid bio-medical waste.


9. That the quantities of solid Bio-medical waste to be received by firm from the member should not exceed more than 0.25 Kg per bed ( i.e. 7.5 kg per bed per month ). If the quantity of waste exceed this limit then additional charge would be levied @ Rs. 50 per kg. Per day.

10 That the member has to take authorization for bio-medical waste/any other authorizations and consents from various department for their institution by themselves. The responsibility of the firm will be limited to issuing an yearly certificate to member of the Common Facility who get their waste has been properly treated & disposal off, so that member may submit it to the concerned department, certified will be issue only after clearing all dues.

11. That the firm will charged the member "i.e. **solid biomedical waste is generating Institution**" on the actual bed strength. In case it is found that the hospital is Operating with extra bed strength from what is given in the agreement the firm Would charge for the extra bed strength for preceding 90 days from date of information and may stop providing services to such institutions in the event the increased dues are not paid days in 30 days. Any increment in the bed capacity is to be intimated to the firm in advance.

12. That this Common Bio-Medical treatment and disposal facility is being set up for collective use , therefore during the term of this agreement and during renewed term if any, the member agrees that the waste generated at their institution will only be treated and disposed off at this Common Facility in accordance with the terms of this agreement and that any other facility for this purpose would not be patronized.
